TERMS AND CONDITIONS OF SPONSORSHIP PACKAGE & EXHIBITION PACKAGE

1. Sponsorship Application & Acceptance

- 1.1. All sponsorship applications shall be processed by NIBM on a first-come first-serve basis. No pre-booking should be made through any member of the WSV2025 Conference Secretariat
- 1.2. Sponsorship/Exhibition Booking is subject to approval by NIBM. NIBM reserves the right to reject any application that does not align with the Conference's objectives.

2. Sponsorship Amount Fees & Payment

- 2.1. Sponsors will only be acknowledged upon receipt of full payment.
- 2.2. All payment must be made at least six (6) months before the Conference date i.e. **7th November 2024**. For applications received **on or after 5th February 2025**, the payment is due immediately (no credit term). Payment can be made *via* the method stated in the application form.
- 2.3. NIBM at its discretion may accept new sponsors in the event the potential sponsor fails to comply with the payment terms.

3. Exhibition Booking

- 3.1 Exhibitors must complete the Exhibition Booking Form. The priority for selection of exhibition booth will be given to the Sponsors but because of the limited booth spaces available, silver sponsors will be on a first come first served basis. The layout is subject to confirmation by the venue operator.
- 3.2 To secure the exhibition booth location, a non-refundable booking fee of 50% of the total exhibition charges must be made within 14 days of the date of invoice issued by NIBM. The balance payment is required before within the stipulated deadline. If the booking is not paid within the stipulated deadline, the exhibition booth location will be released to other exhibitors.

4. Conference Cancellation, Postponement and Relocation of Conference Venue/Exhibition booth

- 4.1 NIBM as the organizer of the Conference, reserves the right, at its sole discretion, to cancel and/or postpone the Conference for any reason. NIBM will notify the Sponsors/Exhibitors on any such changes thereof.
- 4.2 NIBM retains the right to change the Conference's venue. Should such a change occur, NIBM will notify all the Sponsors/Exhibitors as soon as the change becomes definitive. NIBM will use reasonable endeavours to ensure that the Sponsors'/Exhibitors' promotional needs are satisfactorily met.
- 4.3 Should a relocation of the allocated exhibition booth be necessary for reasons including, but not limited to optimizing floor layout or complying with venue requirements, NIBM will notify the affected Sponsors/Exhibitors at the earliest opportunity and will consult with the Sponsors/Exhibitors to identify the most suitable alternative booth, aiming to provide equal or greater value in terms of foot traffic and visibility.

5. Refunds or Cancellations

- 5.1. All cancellations made by Sponsors/Exhibitors must be made in writing to WSV2025 Conference Secretariat. Cancellations made up to and including the 60th day before the Conference date shall result in a deduction of the sponsorship fee/ exhibition charges paid, less any administrative expenses and non-recoverable expenses already incurred by NIBM. Sponsors/Exhibitors who cancel the sponsorship/the participation in the exhibition after this point (59th days or less before the Conference date) will not be eligible for any refund and the sponsorship fee/ exhibition charges paid will be forfeited in full.
- 5.2. Should the Conference be postponed to a later date within one (1) year of the original Conference date due to a Force Majeure Event, the Sponsors/Exhibitors agree to transfer deposits and all benefits under this T&C to such later date. If any of the Sponsors/Exhibitors decide to withdraw from the postponed date, such Sponsors/Exhibitors will be entitled to a refund of 50% of the sponsorship fee/ exhibition charges paid, less any administrative expenses and non-recoverable expenses already incurred by NIBM.
- 5.3. If, for any reason due to the 'Force Majeure Event', NIBM decides to cancel the Conference due to unforeseen circumstances, the Sponsors/Exhibitors will be



- eligible for a refund of the sponsorship fee/ exhibition charges paid, less any administrative expenses and non-recoverable expenses already incurred by NIBM.
- 5.4. For the purpose of Clause 5.2 and 5.3, a Force Majeure Event means an event beyond the control of an affected party, which includes but is not limited to, events that prevent the Conference from being held, such as acts of God, pandemic, epidemics, fires, floods, earthquakes, storms, sandstorms, typhoons, blockades, embargoes, plagues, wars, invasions, acts of foreign enemies or terrorists, acts of civil or military authority, revolutions, riots, explosions, strikes, hijackings, lockouts, civil commotion, insurrection, rebellion, sabotage, or labour disputes. However, Force Majeure Events shall exclude any strikes, lockouts, labor disputes, or other actions primarily instigated by the employees or agents of the affected party.
- 5.5. All refunds shall be remitted to sponsors within 60 days after the completion of the Conference. Sponsors/Exhibitors shall submit the complete refund request form for payment processing.

6. Benefits & Delegate Pass

- 6.1. The benefits offered under the respective sponsorship packages will be implemented only upon full payment of the sponsorship amount.
- 6.2. The benefits are non-transferable and non-exchangeable for cash.
- 6.3. NIBM reserves the rights to: (a) replace the benefits with items of similar value should circumstances beyond NIBM's control arise; and (b) make alternative arrangements regarding the benefits offered, with prior notice should it be deemed necessary to do so.
- 6.4. Sponsor should understand that all attendees must officially be registered. NIBM may refuse admission of attendees from the Sponsors' organization that do not have delegate passes.

7. Exhibition Booth

- 7.1. The allocated booth space is for the Sponsors/Exhibitors' own use only. Sponsors/Exhibitors are not permitted to assign all or any part of its allocated booth space to any other business or firm, unless NIBM has given prior written approval.
- 7.2. Sponsors/Exhibitors undertake that the products and other exhibits to be displayed at Sponsors'/Exhibitors' booth do not infringe or are not likely to infringe any patent, trademark, copyright and other intellectual property right of any party. Distribution of advertising material and Sponsors/Exhibitors' solicitation of any sort shall be restricted to the allocated booth. Sponsors/Exhibitors' products or other exhibits shall not extend into the aisle or beyond the limits of the allocated booth.
- 7.3. Sponsors/Exhibitors shall be bound by the relevant laws and the rules and regulations of the operators of the venue in which the Conference is held.
- 7.4. All exhibits and related items in the venue are displayed at the Sponsors/Exhibitors' own risk. Sponsors/Exhibitors are strongly recommended to obtain full comprehensive all risks insurance for their exhibits and related items.
- 7.5. NIBM shall not be liable for any loss or damage or part thereof of the exhibition goods or equipment prior to, during and after the exhibition.

8. Advertisement

- 8.1. Artwork for advertisements in NIBM's official website or Conference official website or Conference e-program book shall be provided by the Sponsors/Exhibitors by 31th December 2024 or such other deadlines as determined by WSV2025 Conference Secretariat.
- 8.2. The artwork shall be subject to WSV2025 Conference Secretariat's approval. The Secretariat reserves the right to request for an edit of advertising materials should there be any text or image that contravenes the applicable laws.

9. Intellectual Property Rights

9.1. 9.1 Subject to the T&C herein, the Sponsors/Exhibitors agree to grant NIBM the right to use the Sponsors/Exhibitors' trade names, logo designs, trademarks and company descriptions as provided in Sponsors/Exhibitors marketing materials solely in connection with the Conference or as an acknowledgment/recognition as past Sponsors/Exhibitors for any similar future events.

10. Personal Data Protection

10.1.All handling of contact information under this T&C will adhere strictly to the Personal Data Protection Act, 2010.

- 10.3. The names and email addresses of Sponsors/Exhibitors shall be published on the NIBM's official website and/or the Conference's website. The contact information will also be shared with delegates and other Sponsors/Exhibitors to facilitate networking between the participants and with service providers directly involved in the Conference (such as exhibition vendors, venue operators, etc.) to facilitate the fulfillment of their contractual obligations in respect of the Conference.
- 10.4. NIBM assumes no liability for the actions or omissions of third parties receiving the contact information, except as required by applicable laws.
- 10.5. Sponsors/Exhibitors shall have the right to opt-out of having their contact information shared for the purpose of the Conference or future events if the Sponsors/Exhibitors wish to prevent their contact information from being shared.
